#### **STUDENT VOTER REGISTRATION**

The Westchester County League of Women Voters has set a lofty but worthy goal: contact the 100+ public and private high schools in the county about student voter registration.

**REDISTRICTING**

The congressional, state senate, and state assembly district maps that were drawn and approved by the state legislature have been invalidated by a New York State Supreme Court judge. The decision is being appealed. For now, things continue as if the new districts will still take effect for the fall election; needless to say, this has the potential to get even more complicated and confusing.

From LWVNYS:

*In 2014, with the support of the League of Women Voters of New York State, voters approved the establishment of an Independent Redistricting Commission (IRC) to draw new district lines free from partisan bias. A New York State Supreme Court judge's decision today invalidated the new Congressional, State Senate and State Assembly lines adopted by the Legislature on its own initiative. The Court found that the Legislature had failed to follow the Constitutional process approved by voters, and that the Congressional lines also violated the new anti-gerrymandering provisions of the Constitution. The Court ordered the Legislature to submit new maps, with bipartisan support, by April 11, 2022, or the Court will retain a neutral expert to prepare new maps. The Court's decision, if upheld on appeal, unsettles the 2022 election process. That unfortunate outcome is solely the responsibility of the state Legislature for ignoring the 2014 Constitutional amendment and the will of the voters. The League calls on the Legislature to promptly adopt redistricting lines with bipartisan support that comply with the Constitutional standards.*
