### NEW YORK ON PAUSE EXTENDED AGAIN

- > Governor Cuomo has directed the state nonessential workforce to continue to work from home for an additional two weeks, until at least April 29th.
- > In-person workforce restrictions, which have been implemented through various executive orders, are also extended.
- > Statewide school closures are extended by two weeks until at least April 29th.

#### FAQs

#### **Which elections have been postponed?**

>The Executive Order **consolidates the April 28th presidential primary** and special election (27th Congressional District, 12th Assembly District, 31st Assembly District, 136th Assembly District, and 50th Senate District) **with the June 23rd state and congressional primary.**

>School board and village elections have also been postponed but these elections have not been scheduled. The Executive Order states that these elections must occur after June 1st.

#### **Did the registration dates change?**

>May 29 is the last day to postmark a registration form for the June primary; it must be received by the Board of Elections by June 3.

>May 29 is the last day to register in person at your county board of elections.

#### **Did absentee voting change?**

The dates to apply for an absentee ballot have been changed to coincide with the dates of the June 23rd primary

>June 16 is the last day to postmark application for the primary ballot.

>June 22 is the last day to apply in person for primary ballot at your county board of elections.

>June 22 is the last day to postmark ballot, it must be received by the county board of elections no later than June.

>June 23 is the last day to deliver primary ballot in person to county Board of Elections, by the close of the polls.

### **What if I already voted via absentee ballot for the presidential primary?**

At this time the Executive Order does not address that question. Election officials are predicting that all absentee ballots will be preserved and counted in June, but we await more guidance on this question.

### **BIG (AND GOOD) NEWS REGARDING ABSENTEE BALLOTS!!**

**Governor Cuomo has issued an Executive Order stating that ALL voters are eligible to vote via absentee ballot in the June primary.**

The League has long found New York's absentee ballot requirements restrictive but, in light of the Covid-19 pandemic, they were not just restrictive but potentially dangerous. During a pandemic, the health of voters and poll workers are put at risk when people are not allowed to vote absentee.

If you have never voted absentee or are unfamiliar with the process, **you must first fill out an absentee ballot application.**

*We strongly suggest you request an application soon – and once you receive your absentee ballot, we encourage you to fill it out and mail it in as soon as possible. The Board of Elections will likely be overloaded with absentee ballots in light of the rule change.*

### **SCHOOL BOARD ELECTIONS 2020**

In accordance with the governor's executive order, school board and budget votes have been postponed until at least June 1. New dates have not been set as of this newsletter. Please refer to the school district contact information below if you'd like to stay updated regarding the election. If you are interested in running for a seat on your local school board, the Westchester Putnam School Boards Association has postponed its workshop for prospective candidates. It was originally slated for Thursday, April 16. A new date has not yet been determined but will be posted on the organization's website in the near future.

Westchester County is seeking volunteers to help small business owners complete applications for SBA and Paycheck Protection Program assistance.

The Westchester County Office of Economic Development's SBA Application Assistance Program is soliciting volunteers to help

small businesses complete applications for the following programs:

- SBA Economic Injury Disaster Loan Advance
- SBA Economic Injury Disaster Loan
- Paycheck Protection Program applications

Volunteers will be provided training on all aspects of the application process. Training will be developed and conducted in coordination with the SBA and Community Capital New York, a Community Development Financial Institution and SBA-lender. The training will be provided by webinar, and the materials and step-by-step application guides will be provided to the volunteers.

The volunteers will not be providing guidance/recommendations on which loan programs to apply for, but rather will be addressing specific questions on the application(s) selected by the applicant.

### **NEWS FROM THE NATIONAL LEAGUE (LWVUS)**

#### **COVID-19 STIMULUS PACKAGE FALLS SHORT OF ADEQUATE ELECTION FUNDING**

The LWVUS CEO, Virginia Kase, issued the following statement following the U.S. Senate’s unanimous, bipartisan passage of the CARES Act:

“The American people are suffering, and this third stimulus package will begin to get the hard-working people of our country the desperately needed relief they require right now, but one critical element is lacking: adequate funding to ensure voters can safely participate in the 2020 elections.

“The \$400 million included in this third relief deal is a mere fraction of what is needed for all voters to safely cast their ballot with confidence this November. The League of Women Voters called for a minimum investment of \$2 billion dollars to states and the District of Columbia to appropriately increase vote by mail, expand early voting and online registration, and implement safety provisions to ensure voting facilitates and poll workers are protected.

“These are unprecedented times, as we see states across the country delaying elections in order to keep voters safe. Now is the time for legislators to appropriately safeguard the 2020 elections and instill confidence in the voting public.

“If Congress is serious about preserving the integrity of our elections, funding needs to be a priority in the next stimulus package.

“The League of Women Voters stands ready and willing to work with lawmakers to appropriately plan and implement the flexible measures that will ensure our November elections are safe and accessible for all.”


